# **Single Procurement Document (SPD) - Word Document Retiral**

## **Transition to a fully online SPD process from 1 April 2024**

As per our previous correspondence, we would like to remind you that from 1 April 2024 the Word version of the Single Procurement Document (SPD) will no longer be supported or updated by Scottish Government

Following user research, the Word version of the SPD will be removed from the [Procurement Journey](#) website on 31st March 2024. All of the guidance relating to the SPD and the supplier selection process will continue to be available.

From this date, the fully online versions of the SPD, available within PCS and PCS-Tender, will be the only ones updated, supported, and maintained by Scottish Government.

## Why are we making this change?

The precursor to the SPD, the ESPD, came into force in April 2016. In the eight years since then, the online capability of both buyers and suppliers has increased dramatically, just as it has for the general population, and the pandemic has further increased the rate of transition. The SPD was always intended to be an entirely online process, and this change will simplify the landscape, especially for SMEs, who have told us that continued support and use of the offline SPDs causes them issues when engaging with public procurement in Scotland.

## What does this mean for me?

If you're already using PCS-Tender, or the SPD module in PCS to run your procurement exercises, then you should continue to do so.

If you currently use the Word version of the SPD, (or any other offline version) to create your SPD requests, then you are advised to familiarise yourself with SPD functionality within PCS as soon as possible.

## **What are the benefits of using the SPD module within PCS?**

The SPD module is designed to be 'self-contained' and this means that buyers can include any requirements specific to their procurement exercise, such as qualifications, experience, financial stability etc, within their SPD request. Buyers can also request and receive supporting evidence, such as copies of company accounts, certifications relating to quality management, environmental management and other 'means of proof', from within the system.

For suppliers, it simplifies and streamlines the selection process, enabling them see the buyer's requirements within the SPD itself, without the need to cross refer to other procurement documents. Suppliers are also able to store and re-use their answers to standard SPD questions, and upload evidence documents, such as company accounts, once but use them multiple times.

The SPD module is integrated into PCS, so there's no need to re-register or create a separate log-in.

## **What if I need to share my draft SPD with my user intelligence group members, or other stakeholders who don't use PCS?**

The SPD module with PCS enables you to export your SPD request in various formats, including PDF and Word, which can then be shared with other stakeholders for review or comment.

## **Does this mean I will no longer be able to use an SPD Word attachment in PCS?**

Buyers will still be able to use a Word, or other offline version of the SPD, and issue it as an attachment, but this approach will not be actively promoted or supported by Scottish Government. It would be the responsibility of individual buyers and contracting authorities to ensure that any offline versions of the SPD remain aligned to the latest official Scottish Government versions within PCS and PCS-Tender and to seek their own legal advice to support this.

## **Single Procurement Document (SPD) Wording Updates - 25 March 2021**

Question 3D.15 Misrepresentation (an exclusion question in the SPD (Scotland) ) has been updated - the text changes are shown at the end of this message.

Since the ESPD was launched in April 2016, there have been several instances where the wording of this particular question has led to confusion as to how it should be answered by bidders. The confusion arises mainly because all of the other questions in the Exclusion Criteria section required a bidder to provide a negative, “no”, answer in order to indicate compliance, whereas the *Misrepresentation* question required a positive, “yes”, answer.

Following consultation with both buyer and supplier representative bodies the text of this question is being simplified so that it also requires a “no” answer in order to indicate compliance, which will bring into alignment with all of the other Exclusion Criteria questions in the SPD.

From 25 March any new SPD requests you create from one of the centrally-controlled versions above will automatically contain the updated version of the question. Any locally stored versions of the SPD you may have should not be used after this date.

If you’ve issued an SPD request before this date, but the return date isn’t until afterwards, don’t worry, the SPD you’ve issued is still perfectly valid with the old

version of the question. However, it may be prudent to seek clarification from any bidders that appear to have answered this question incorrectly, before making any decisions to exclude them a competition.

Additional minor wording amendments to simplify the questions are being made. These will not fundamentally alter the meaning of these questions, and no action is required from buyers or suppliers. The questions affected are 2A.16, 2A 16.5 and 3D.11. You can view these changes on the SPD Update area on PCS from 25 March.

Both the Public Contracts Scotland SPD (module) and PCS-T have been updated with these changes.

**Current wording:**

Can the bidder confirm that:

- 1) It has not been guilty of serious misrepresentation in supplying the information required for the verification of the absence of grounds for exclusion or the fulfilment of the selection criteria
- 2) It has not withheld such information
- 3) It has been able, without delay, to submit the supporting documents required by an organisation or contracting entity, and
- 4) It has not undertaken to unduly influence the decision making process of the organisation or contracting entity, to obtain confidential information that may confer upon it undue advantages in the procurement procedure or to negligently provide misleading information that may have a material influence on decisions concerning exclusion, selection or award?

**Revised wording:**

Has the bidder:

- a) Been guilty of serious misrepresentation in supplying the information required for the verification of the absence of grounds for exclusion or the fulfilment of the selection criteria,
- b) Withheld such information,

- c) Been unable, without delay, to submit the supporting documents required by an organisation or contracting entity,
- d) Undertaken to unduly influence the decision making process of the organisation or contracting entity, to obtain confidential information that may confer upon it undue advantages in the procurement procedure or to negligently provide misleading information that may have a material influence on decisions concerning exclusion, selection or award?

Annual Procurement Report

In addition to the mandatory procurement strategy, to meet regulatory requirements the organisation must now also prepare and publish an [annual procurement report](#) disclosing how its procurement activity has complied with its published procurement strategy.

The [Procurement Reform \(Scotland\) 2014 Act](#) lists the minimum requirements that the annual procurement report must contain. The Annual Procurement Report Guidance and Template below provides further guidance on the information an organisation needs to include in its annual procurement report to meet its legal reporting obligations, as well as providing information on other content that an organisation may choose to include.

The procurement strategy/revised procurement strategy and annual procurement report should be published in a way that the organisation considers appropriate, but must include publication on the internet.

[SPPN 7/2020](#) provides details of how a contracting authority should notify Scottish Ministers of the publication of its annual procurement report covering financial year 2019-20, including completing and submitting the template provided at Annex A. This SPPN also provides information on notifying Scottish Ministers of the publication of a revised procurement strategy.
